**2 Minutes of Meeting on 22 July 2015**

2.1 Approved.

**3 Plan: Discussion on Vision and Policies DC1-DC5**

3.1 The meeting spent a considerable time, c.1½ hours, discussing the wording of the 'Vision' and of the 'Design and Character Policies, DC1-DC5' in the draft of the Plan dated 7 July 2015.

**ACTION:** Ellen will circulate a revised version of the Vision and Policies DC1-DC5, incorporating the wording discussed and agreed in the meeting.

ACTION: In relation to DC4(f), Ellen will contact Camden Council for an update on the Council's current proposals in relation to basements.

#### **4 Plan: Actions and responsibilities**

- 4.1 The meeting noted that work in relation to the various actions and responsibilities discussed at the meeting on 22 July 2015 is ongoing. The meeting noted, with thanks, that Ann and Catharine have produced a list of Community Assets for consideration and discussion. The actions and responsibilities will be discussed further at the next meeting.

#### **5 York Rise Street Party**

- 5.1 After careful consideration, the meeting decided not to have a stall at the York Rise Street Party on Sunday 13 September 2015. The Committee needs first to develop the wording of the Plan further and then to report back to the Community.

#### **6 Committee membership**

- 6.1 **Co-optees:** Kelly is waiting for a response from David Kohn, and mentioned also that her daughter, aged 14, would be happy to assist if this would be helpful.
- 6.2 **Declarations of Interest:** Grace, Kay, Patrick, Sally, Siân and Valerie have not yet provided Declarations of Interest. The meeting noted, again, that these are an essential aspect of corporate governance under DPNF's Constitution.

#### **7 Funding**

- 7.1 The meeting noted, with thanks, that Ben has made an application for £1,000. A response should be received within about a fortnight.

#### **8 Website / Social Media**

## **9 Kentish Town Neighbourhood Forum**

KTNF wish to have DPNF's comments and thoughts in relation to (i) the view from Kentish Town tube station across to the Heath and (ii) Murphy's Yard. The meeting discussed this and agreed that DPNF is not yet in a position to form a firm view on these matters.

ACTION: Ellen to respond appropriately to KTNF.

## **10 Power Up North London**

- 10.1 Apparently PUNL wish to discuss with DPNF a proposal to put solar panels on St Anne's Church. It seems a surprising proposal, but the meeting agreed that DPNF needs to find out what is intended. Kelly volunteered to speak with PUNL.
